

Terms of Use primtech INSIDE

1. Acceptance and scope

- a. These Terms of Use apply to the use of the online login area primtech INSIDE (“Portal”) by primtech Resellers and primtech Subscription Customers (both “User”) of the information, products and services contained within Portal. The Portal is operated by entegra GmbH (“entegra”). The Portal is governed by these Terms of Use.
- b. This legal notice applies to the Portal according to Sec. 5 German Telemedia Act (TMG).
- c. entegra has the right to update these Terms of Use at any time without prior notice to the users. The current version is available online.
- d. Only access to the Portal if you - the User- agree on these terms of use. Do not access the Portal if you do not agree to these Terms of Use.
- e. When registering for the Portal, entegra will save the personal data (like Name, Email, ...) entered in to the registration form. entegra will use this data solely in connection to the Portal (like creating and managing your account, contacting you, ...) and will not be passed on to third parties.
- f. These terms of use do not supersede the Reseller Agreement (“RA”) or Software License Agreement (“SLA”). In case of conflicting terms, the RA and SLA take precedence.
- g. The use of primtech INSIDE is only for license holders who have accepted the SLA and are in possession of a valid primtech Subscription License.

2. General terms of use

- a. entegra explicitly reserves the right to withdraw access to the Portal temporary or permanently.
- b. Users must register and log in before using the Portal.
- c. Users must have an active primtech Subscription Agreement.
- d. All content, including media and software content, is only for use by the User and not any other person, company or entities.
- e. Two (2) primtech INSIDE logins can be requested for each purchased primtech Subscription License.

3. Account, Password, Security

- a. To receive a username and password (“Login Data”) for the Portal the potential User must provide entegra with current, complete, accurate information in the registration form.
- b. The Login Data provided by entegra is strictly for personal use only. No other person is allowed to access the Portal with the User’s Login Data.
- c. The User hereby agrees to inform entegra when he leaves the Company that is in possession of the Subscription License. The right to use primtech INSIDE expires as soon as the User ceases to work for license holder.

- d. The User is responsible for maintaining the confidentiality of the provided password and username and hereby agrees not to transfer login data to any third party.
 - e. The User is responsible for all activities carried out with the User's account.
 - f. The User agrees to notify entegra immediately in case of any abuse, unauthorized access or use or any suspicious activity especially concerning security issues regarding your account or the Portal itself.
 - g. entegra is not responsible or liable for the loss of your Login Data and any activities and damage arising by and while using your account.
 - h. entegra reserves the right to deny the access of any User at any time. This might be considered, particularly where there are reasons to suspect misuse of the Portal.
4. Notice regarding Portal, software, documents, videos or further content available
- a. In no event will entegra be liable for any direct, indirect or consequential harm or damage arising out of or in connection to the use of the Portal including software, videos, documents and other content available via the Portal.
